# Information Technology

### Strategic

1. Support the development and recognition of academic and research librarians as leaders and experts in information technology applications in libraries

#### Activity

Sponsorship of NJLA College and University Section Technology Innovation Award. This award honors a librarian or group of librarians for innovative use and application of technology in a New Jersey academic library. The award may be given either in recognition of a specific project, or for ongoing delivery of innovative technology applications. The purpose of the award is to recognize distinguished leadership in developing new technologies for academic libraries. The award is based on the benefits of innovation/use of technology to library users, benefits of innovation/use of technology to information community,impact of innovation/use of technology on library operations and impact of innovation/use of technology on perception of the library/librarians in the academic setting.

#### Activity

The Distinguished Service Award went to Norma Blake, State Librarian for her work on advocting for the New Jersey Knowledge Initiative with the New Jersey Legislature and the Governor. She worked with the New Jersey Library Association, NJ VALE academic libraries, and the four regional library cooperatives that comprise the NJ Library Network to advocate for a new appropriation of \$6 million to provide free access to high-end, proprietary databases in the fields of science, medicine, technology and business. This new program will spur economic growth and strengthen high tech initiatives in the state. Through this program academic libraries will become essential partners in business development and high tech research.
